"[Virginia] Governor McDonnell established the group to provide a scientific policy analysis to help assess whether the moratorium on uranium mining in the Commonwealth should be lifted, and if so, how best to do so. The Directive sets out eighteen tasks for the UWG to complete, including the creation of a draft statutory and conceptual regulatory framework which the UWG will present in the series of public meetings listed below. The UWG will provide its findings and final report to the Governor and in turn the Uranium Mining Subcommittee of the Coal and Energy Commission."

The working group completed its work as of 30 November 2012 and was then dissolved. The group's website is maintained for historical purposes, but is no longer active. The group's final report is available for download – to find it, use the links provided at the website listed above.
