



**OBJET : Audience publique sur le projet de lieu d'enfouissement technique à Danford Lake dans la municipalité d'Alleyn-et-Cawood**


Monsieur le Ministre,

La Municipalité régionale de comté (MRC) de Pontiac désire un examen public du projet de lieu d'enfouissement technique (LET) à Danford Lake dans la municipalité d'Alleyn-et-Cawood et souhaite participer à une audience publique. Les motifs de notre demande et notre intérêt par rapport au milieu touché par le projet sont les suivants :

- L'implantation d'un LET pourrait être à court terme une solution régionale à la problématique d'élimination des matières résiduelles ; en effet, les quelque 50 lieux d'enfouissement en tranchée (DET) de la région de Outaouais seront fermés le 1<sup>er</sup> janvier 2009, conformément au Règlement sur l'enfouissement et l'incinération de matières résiduelles, et les solutions de recharge, particulièrement celles de la MRC de Pontiac, sont quasi inexistantes ;
- Le projet de LET se situe dans la municipalité d'Alleyn-et-Cawood dont le territoire est compris dans celui de la MRC de Pontiac ; ce projet concerne toute la population, qu'elle soit permanente ou saisonnière, non seulement dans cette municipalité, mais aussi dans toutes les autres municipalités de la MRC de Pontiac et plusieurs autres dans la région de l'Outaouais ;

- L'implantation de ce LET aura un impact significatif sur les communautés avoisinantes, tant sur les plans environnemental, économique et social.







Our family has owned a cottage on Danford Lake for over 75 years. Although I am a resident of Canmore, Alberta I return to Danford Lake every summer to vacation at the family cottage. I am extremely distressed about the proposed landfill site near the Village of Danford Lake. Not only do I have a vested interest because of my future inheritance of the family cottage, I am very concerned about environmental issues in general. Protecting the environment is one of the most important issues facing Canadians today.

Quebec has an obligation to not only the residents of the area, but to the community at large to hold public hearings on this project. The ramifications of this project are huge. It impacts not only the residents, but the potential tourist business as well.

I am concerned about a great variety of issues -

- Negative environmental impact on the surrounding waters, soil, flora & fauna.
- Increased truck traffic on highways 105 and 310 (these highways are inadequate for the present traffic load, let alone the dramatic increase in truck traffic associated with the proposed landfill) and the associated increase in noise, air pollution, highway garbage, fuel consumption & emissions from the trucks, increased collisions and loss of human lives etc.
- Greenhouse gas emissions from the proposed landfill site.
- Air quality (smell) from the proposed landfill site.




I hereby request that Public Hearings for the proposed Danford Lake Landfill Site be held for this project, as I am concerned that this proposal may have a significant impact on the safety of the roads in the surrounding Danford Lake area.

The proposed landfill site is being considered in an area which has a high volume of truck traffic at present, and any additional traffic will make these roads unsafe to travel.

I also request that the BAPE public hearings be held in other locales in order to gain the full breadth of the feelings of the people living and working in this area. Hearings should be held in Gatineau, as well as Danford Lake, Kazabazua, Low and Lapeche.

In addition to the truck traffic safety issues, the BAPE public hearings should look at alternatives to landfills. As you are aware, there are many such successful waste-into-energy technologies operating elsewhere in the world. LDC's proposal of "bury and forget" type of solution is not acceptable in this modern environment. 

I am requesting that Public Hearings be held through B.A.P.E. because I am extremely concerned regarding the integrity and honesty of the Promoter of this project. After attending the BAPE meeting last night in Otter Lake, my fears have heightened!

This promoter seems intent on building this 'Engineered Landfill' no matter what the consequences are. In this day in age, I cannot conceive of why something like this would even be considered.

There are other ways of handling garbage, with new technologies, and I have read that a few municipalities are looking into these alternatives. However, after the meeting last night, if this promoter is given the 'O K' by the Government to go ahead with his project, he will obtain 'trash' from other sources to make the dump financially viable. Thank you in advance for your consideration in this matter.





My name is Anne Argue and I am a taxpayer of the Municipality of Kazabazua.

I am writing to request that public hearings be held on this project. I have numerous concerns, the uppermost being the increased traffic on what already is a busy and at times dangerous highway.

Secondly I am not convinced of the wisdom of locating a huge garbage dump in a location where the potential to contaminate the Picanoc and Kazabazua River exists. Residents on the Ontario side living near the Carp Dump have certainly had issues with contamination of their water systems and fouling of the air despite that landfill owners assurance that liquid seepage and odour would be controlled. How will this be any different?

I am also concerned about the possibility that if this landfill opens it will be available for out-of-area and out-of-province use.

I would also request that public hearings be held in Gatineau and/or in the municipalities that would be most affected by the project (Danford Lake, Kazabazua, Low, LaPêche).





Dear Sir,

My name is Read Sherman and I am a part-time resident of the Municipality of Kazabazua, and minister at Trinity United Church in Kazabazua and Low United Church in Low. Danford Lake is part of my parish, where we hold summer services at Danford Lake United Church on Highway 301 in Danford village.

I am deeply concerned about the impact the proposal to locate a large, regional landfill in Danford Lake has had on that community, and could have on the communities immediately adjacent to Danford Lake. There are a number of issues (as outlined below) which impact upon the potential health and safety, not to mention the quality of life, and potential for economic and residential growth, which are very far from settled in the minds of the public. In addition, God has blessed this area with a pristine environment that is a gift to us all, and a gift worth carefully protecting. For these reasons, I urge you to hold public hearings on this project.

In making this request, I am aware of the legitimate and laudable desire of the landfill promoters to boost local employment opportunity, and tax and royalty revenue to their municipality. These are excellent goals, but I ask regarding this proposal, at what cost? I have watched as good people on both sides of the issue in Danford Lake have turned against each other – this in a small, tightly knit community where people have lived together in many cases for generations. My feeling is that public hearings will allow each side, and perhaps other, new, emergent voices, to air fully their hopes and concerns about the proposal. My hope is that the hearings would perhaps allow alternatives to be raised that the whole community could support.

The public hearings would also go a long way to demystifying your government's role in adjudicating the permits and approvals – which in the long run will help create positive connections between the area population and the provincial government, which can often seem so distant to those living in the Outaouais.

Primary issues that would need addressing in the hearings include:

- Increase in truck traffic (on the 105, 301, and 148)
- seepage of liquids from site
- import of out-of-province or out-of-the Outaouais waste
- impact on fauna and flora
- greenhouse gas emissions from site

Of direct impact to me personally is the possibility of increased truck traffic on the 105, since my residence faces directly onto the 105. Trucks blast by from early morning until late at night, rattling windows and making noise. The same is true at Trinity United, also located on the 105. Another concern are the cemeteries of my parish, which include Hillcrest in Aylwin (directly on the 105, with no parking for mourners other than on the shoulders of the highway) and the Pineridge Union Cemetery on the 301 (same issue, with parking only along the shoulders). The road is already so crowded with tractor trailers from the logging industry that it is inconceivable to me how adding garbage trucks to the mix can be sustained from a noise, pollution and road-wear point-of-view. I am also concerned about the safety of the thousands who use the 105 every day, including individuals, families, and school buses.

For these reasons, I would request that public hearings be held in Gatineau and in the municipalities that would be most affected by the project (Danford Lake, Kazabazua, Low, LaPêche). Last but not least, I request that the BAPE's mandate include looking at alternatives to landfills, such as waste-into-energy technologies.

Thank you for considering the issues I have raised. As a Christian minister, I have deep empathy for the good hearts of the residents on both sides of this very divisive proposal. I truly believe an inclusive, transparent process led by BAPE will help you and your office make the best possible decision.

As you know, that decision will have a lasting impact on those who call Danford Lake and the surrounding region home for years, even generations to come. I offer my prayers that God may be with you in the responsibility entrusted to you, and thanks for the important work you do on behalf of us all.
