Renato,

The existing planning by-laws of the Municipality of Alleyn-et-Cawood have been in force since 1991. There are still in force today. The Municipality told me that Lac Miljour is situated in a recreation zone in which chalets or seasonal homes are allowed (chalets and seasonal homes are compatible uses with other uses of the same nature because they refer to recreation and tourism).

After the coming into force of the Revised Land Use Planning and Development Plan of the MRC of Pontiac, on February 23rd, 2001, the Municipality of Alleyn-et-Cawood had two years to adopt concordance by-laws (amendment by-laws to the planning by-laws to conform with the Revised Land Use Planning and Development Plan), in accordance with the provincial Act respecting Land Use Planning and Development. The MRC of Pontiac is still waiting for receiving those concordance by-laws to approve them and to make them be in force. To my understand, the recreational zoning at Lac Miljour is still existing.
